Preamble: The United Nations' Objectives in Forestalling Wars, as well as Promoting Peace and International Security: As the primary intergovernmental organization tasked with maintaining global peace and security, the United Nations has a crucial and wide-ranging mandate in this domain. Established in the wake of the devastating World Wars, the UN was founded on the principles of preventing future conflicts, protecting human rights, and fostering international cooperation.

At the heart of the UN's objectives in the realm of peace and security is the fundamental desire to save succeeding generations from the scourge of war. The UN Charter explicitly states the organization's commitment to "take effective collective measures for the prevention and removal of threats to the peace, and for the suppression of acts of aggression or other breaches of the peace."

You are expected to carry out an independent research and **ANSWER THE FOLLOWING QUESTIONS** from your findings.

Assess the effectiveness of the United Nations in addressing major global crises, such as the ongoing conflicts between *Russia and Ukraine*; *Israel and Palestine*; *the crisis in*; *The DRC Congo and Sudan*. In your response, you should:

- 1. First, familiarize yourself with any of the above conflicts (of your choice)
- 2. Identify the CORE problems or causes of the conflict (preferably 2 major problems)
- 3. Explain the key responsibilities and powers of the United Nations in responding to international conflicts and ensuing humanitarian emergencies. **10marks**
- Analyze how (If at all) the United Nations has attempted to mediate, negotiate, and impose diplomatic solutions in the country of your choice (above)
 10marks
- Discuss (In your personal thoughts) the challenges the UN faces in effectively resolving complex, protracted conflict in the case study you picked and propose ways the organization could enhance its crisis response capabilities.
